### BALLOT ISSUE 1A

WITHOUT INCREASING THE TAX RATE AND WITHOUT ADOPTING ANY NEW TAX, SHALL ARAPAHOE COUNTY BE AUTHORIZED TO COLLECT, RETAIN AND SPEND REVENUE THAT EXCEEDS ARTICLE X, SECTION 20 LIMITATIONS, BEGINNING JANUARY 1, 2025, AND CONTINUING EACH YEAR THEREAFTER, WITH THE FUNDS USED TO ADDRESS ESSENTIAL COUNTY SERVICES AND NEEDS, SUCH AS:

- REPAIRING, MAINTAINING, AND IMPROVING COUNTY ROADS, BRIDGES, AND TRANSPORTATION SYSTEMS, INCLUDING SNOW PLOWING, FOR MORE THAN 1,265 LANE MILES OF NEIGHBORHOOD STREETS AND COUNTY ROADS;
- CRIME PREVENTION AND RESPONSE BY THE SHERIFF’S OFFICE, INCLUDING OFFICERS, STAFF AND EQUIPMENT, MENTAL HEALTH CO-RESPONDERS, AND 24/7 NEIGHBORHOOD PATROL AREA COVERAGE;
- HOUSING SOLUTIONS, HOMELESSNESS PREVENTION AND RESPONSE, PROTECTIVE SERVICES FOR VULNERABLE CHILDREN, YOUTH AND OLDER ADULTS, AND MENTAL HEALTH RESOURCES;

PROVIDED THAT ALL SPENDING OF SUCH REVENUES BE REPORTED IN THE COUNTY’S ANNUAL INDEPENDENT AUDIT PUBLISHED ON THE COUNTY WEBSITE AND MONITORED AND REVIEWED BY A RESIDENT ADVISORY COMMITTEE AND THAT ANY INCREASE OF THE MAXIMUM ALLOWED TAX RATE OF 15.821 MILLS REQUIRES ADDITIONAL VOTER APPROVAL; AND SHALL ALL SUCH REVENUES BE COLLECTED, RETAINED AND SPENT NOTWITHSTANDING SECTION 29-1-301, C.R.S., SECTION 29-1-1702, C.R.S. (IN THE EVENT SUCH LIMITATION BECOMES LAW) AND ANY OTHER REVENUE OR EXPENDITURE LIMITATION PROVIDED BY LAW?

# ARAPAHOE COUNTY

## **Summary of Written Comments For Issue 1A:**

Voting Yes on 1A means investing in Arapahoe County services our community deserves. This revenue will address unmet needs in public safety, housing, and road improvements, among other essential services including:

- Improved road quality;
- Reduced congestion;
- Traffic mitigation;
- Pedestrian and bike safety;
- Sheriff emergency response;
- Neighborhood safety;
- Housing affordability & availability; and
- Mental health resources.

1A allows the county to retain about \$74 million more in years with higher tax revenues - without increasing the tax rate and without adopting any new tax.

This funding will also be used to address the \$316 million backlog of deferred road maintenance and important transportation projects in the county.

What if 1A doesn't pass?

- If 1A fails these local services will be impacted by significant budget cuts starting in 2025.
- These cuts could include \$3.7 million from public works and transportation, \$12 million from the Sheriff's Office, and \$8.6 million from human services, to name a few.
- It is clear that the quality of life we enjoy today in Arapahoe County would be directly impacted.

## **Summary of Written Comments Against Issue 3B:**

Ballot Issue 3B is a sin tax – a tax to incentivize desired behavior. The message is: Don't smoke; especially, don't smoke pot. It assumes the marijuana smokers won't protest by purchasing out of city or growing their own.

Government always has worthy projects: for the children (LPS), for the parks (SSP&R), for the roads (2021 & 2023), for arts and culture (lodging tax 2022) and now to milk or discourage marijuana use (here in 2024).

Economics is unlimited demands being placed on limited resources. Enough is enough.

- Fiscally responsible marijuana users are going to:
  - purchase out of town or
  - grow their own or
  - purchase in town on the illegal market.

The City does not have a monopoly.

- Most communities realize too late (California's doom loop, New Jersey and New York butt taxes) over taxation is counterproductive. Rarely does City Council ask "When is enough, enough?", and even more rarely do they answer that question. Have we heard what is the optimum size of government?

We have not heard what tax will be requested after 2024. We have not seen a graph of the last ten years of city population versus city employees versus taxes versus inflation as was requested in last year's tax con statement.

We need more specifics, transparency and certainty!

Again, vote no on Ballot Issue B.

## Summary of Written Comments For Ballot Issue 4A:

YES on 4A – Step 1: Safe, Secure Schools and Recruit and Retain High Quality Teachers

The Cherry Creek School District (CCSD), Yes on 4A, is dedicated to growing its excellence with high-quality teachers, safe and secure schools, rigorous curriculum, and innovative programming.

Under the 1994 School Finance Act, Colorado school districts receive a fixed amount of per pupil funding that comes from a mixture of both local property taxes and state taxes. School districts do not receive more funding when local property taxes increase, it simply reduces the amount the state contributes but the bottom line stays the same. The only way for school districts to receive more funding is to ask their local voters.

With that in mind, CCSD is asking taxpayers to grow and invest in the operations of the district with a 5% Mill Levy Override increase, phased in at approximately 1% a year, resulting in a \$9 million infusion in year one to ensure CCSD's academic excellence and maintain high property values.

This opportunity is made possible by the new School Finance Act formula enacted by the Colorado State Legislature during the 2024 session, which provides voters in certain areas of the state the ability to increase their local Mill Levy Override. This is a one-time opportunity that must be utilized during the next six years. Many school districts are taking advantage of this as there are no assurances this funding opportunity will remain in effect for the entire period.

When the opportunity to grow our excellence presents itself, the CCSD community is known for supporting its students and staff to ensure their local schools have the financial resources they need to develop our future workforce.

As prudent, responsible stewards of taxpayer dollars, CCSD spends almost 91% of its operating budget on people. Less than 4% is spent on administration, which includes principals and assistant principals.

Here is what YES on 4A means for our community:

- Increase trained safety and security staff to protect students and staff
- Retain and recruit high-quality, experienced teachers
- Keep CCSD schools competitive with metro area schools
- Maintain strong property values
- Develop a strong workforce of the future and significant investment into our local economy

Add a Career and Technical Education (CTE) medical wing at Byers Secondary which allows for continued “hands-on” learning for students today and for generations to come. Career and Technical Education gives students the practical skills they need to succeed in today’s economy. Expanding CTE spaces will allow more students to pursue these valuable programs, helping to ensure they are job-ready upon graduation.

Add an expanded gymnasium at Byers Secondary which will provide a large enough facility to host elementary and secondary cultural events, including concerts, plays and all other activities. In addition, the expanded recreational space will be accessible to the community in the evenings. This initiative maximizes the use of the school facilities, making them a shared resource. It is a smart, efficient way to use tax dollars for the benefit of both students and the community at large.

The last Bond was approved in 1999 and paid off two years early by the school district. By passing this bond issue, which would cost a homeowner approximately \$11.00 per month per \$100,000 of value, the community can show its support for our children. # POLO RESERVE METROPOLITAN DISTRICT

## **Summary of Written Comments For Issue 6A:**

The Polo Reserve Metropolitan District's current mill levy rate is not sufficient to maintain the District's current maintenance and repair needs for the irrigation system and public landscaping areas nor to fund reserves for capital improvements such as the irrigation pump station. In fact, from the formation of the District in 2005 the fixed mill levy equivalent to a flat rate of about \$78,000 has been and will continue to be inadequate. In the absence of our Polo Field contractor, which is not future-guaranteed, the District will not be able to maintain the polo fields in their current status. A YES vote on Ballot Issue 6A will help the District to fund necessary annual operating, maintenance, and capital reserve costs. The current irrigation system and surrounding landscapes are in ongoing need of repair and upgrades, coupled with inflationary pressures significantly driving costs up, all lean to increased maintenance costs. All current property tax revenue (only approximately \$78,000 annually) is dedicated to funding in part current year operations, leaving inadequate funds for contributions to the Capital Projects Fund to pay for larger upgrades or repair projects. Due to this, the General Operating Reserves has been dwindling annually by approximately \$30,000 or more (over \$60,000 in 2024).

Investing in our beautiful polo fields and adjoining landscaping elevates the aesthetic appeal of our neighborhood. Healthy landscapes reduce erosion, manage stormwater, and create inviting spaces for wildlife and recreation.

This funding will enable us to maintain our existing infrastructure and carry out necessary repairs and upgrades, ensuring that our Nevada Ditch Trail and adjoining spaces remain vibrant and accessible for all users. Moreover, it will provide the necessary resources for long-term planning and improvements, allowing us to adapt to changing environmental conditions and community needs.

By approving this measure, we are making a commitment to the future of our community—one that values beauty, sustainability, and the quality of life for all residents. Without this increase, much needed maintenance and repair projects will remain unfunded and the property will lose its appeal over time.

## Summary of Written Comments For Ballot Issue No. 7A:

Passage of Ballot Measure 7A will allow RTD to keep and expand mass transit options across the metro area, all without raising taxes at all. A Yes vote on 7A will help to maintain current levels of bus and rail services, repair and improve rail lines, buses, bus stops, stations, and other infrastructure, maintain the availability of services for people with disabilities, provide transportation services for youth 19 years of age or younger at reduced or no fares, fund security and safety measures on RTD rail lines, and more.

Since 1995, voters have waived RTD's TABOR cap multiple times, allowing RTD to keep the money it raises. The waiver expires partially again this year. Voting "Yes" allows RTD to keep the money it already raises. RTD will still need to follow TABOR requirements, such as seeking voter approval for new or increased taxes or bonding authority.

People with disabilities, commuters, students, seniors, and many others that may have no other means of getting to where they need to go depend on RTD's buses and trains. Reliable public transit is crucial for getting people to work school and essential services. A strong transit system supports local businesses by providing affordable transit options for employees and customers, contributing to a robust local economy.

A well-funded RTD reduces the number of cars on our roads, alleviating traffic congestion and shortening commute times for both transit users and drivers. Public transportation reduces greenhouse gas emissions and air pollution by decreasing the number of vehicles on the road and contributes to a healthier environment. And 7A makes this possible, without raising any tax at all.

Like many transit systems, RTD's infrastructure is aging and requires ongoing funding. Retaining funds ensures necessary repairs can be made, preventing larger, more costly issues in the future.

IF RTD's TABOR cap was in place in 2022, RTD would have had to cut approximately \$50 million from their budget resulting in less money to keep buses and trains safely and reliably moving.

By voting "Yes" on 7A, Coloradans can invest in a more connected, efficient, and sustainable transportation network that benefits everyone in the region. We have the chance to support essential services, promote environmental sustainability, and maintain fiscal responsibility – all without imposing new taxes or increasing tax rates.

## Summary of Written Comments Against Ballot Issue No. 7A:

Even the strongest supporter of mass transit must rethink this tax. It's not a good idea nor is it the right time. Vote NO on the measure.

- Ridership is way down. It dropped to only 65.2 million "boardings" in 2023, when it had been 103.2 million boardings in 2019. That's a huge drop. RTD wants this for ongoing operations, but that level of spending no longer matches the ridership.
- Management has not kept riders safe. Many people avoid using buses and light rail due to the dirty needles, assaults, open drug use, filth and crime.
- Management does not operate intelligently. How many times have long stretches of the rail system been shut down? Poor maintenance has left some rail routes going no faster than 10 miles per hour, keeping commuters from getting to work on time. Bus routes suffer reliability issues.

Lifting the TABOR budget limits would be a FOREVER tax. No sunset date. No revisiting it later.

Having no limit on budgets paid off construction debt of \$779 million over the past 25 years. The project was built and paid off. The old tax scheme has ended. This extension is a tax increase by keeping what otherwise would be returned to you. If it were not a Taxpayer's Bill of Rights requirement to vote on renewed taxes, it would not have to go to the ballot. When politicians mislead you to get your vote, it should be a red flag.

There is no plan to use this renewed tax plan for new bonds, and the revenue would just get dumped into the general fund. Vote down this tax extension and give RTD the opportunity to come back with specific ideas and costs, instead of a blank check for who-knows-what.

The state legislature has been seriously considering removal of an elected Board of Directors. We don't even know who will be controlling the tax increase in a few years!

RTD charges you sales tax on a vast majority of goods, taking money out of your pocket when you buy toilet paper, school supplies, clothing, and groceries. It adds up, the average taxpayer gives up a few hundred dollars to RTD each year in sales tax. Have you gotten your money's worth?

The system needs to be fixed first. Taxpayers should demand some accountability. RTD must first use current dollars to reverse ridership decline and move to a transit system that is not inefficient, inconvenient and even dangerous. Giving RTD this money does not necessarily mean that light rail will go faster than 10 miles an hour or clean up the stations, buses and trains. Just having a bigger budget does not guarantee reforms. Don't throw good money after bad.

Vote NO and keep your RTD TABOR refund.
